Dear Skater/Parent,

Your membership with the United States Figure Skating Association (USFSA) expires on 6/30/2021. If you plan to skate, test, attend camps or compete this summer, it is necessary to renew your membership now rather than waiting until later in the season. **You must renew your membership now for any summer tests to be validated by USFSA.** We do understand that some skaters may not skate over the summer and prefer to wait and register in September. That is fine, but there will be a lapse in your USFSA membership during July and August.

USFSA charges the Club a service fee each time we renew memberships. Therefore, to help save money, we will be doing a large renewal at the end of June and one in September. If your USFSA membership payment is received by June 29, 2021, it will be part of our June 30th renewal and the Club will pay the service fee. If your payment is received between June 30, 2021 and September 1, 2021, you are responsible for the service fee (\$5) to have your membership renewal submitted individually.

Please print and complete the form on the next page for each family member and mail the form with a check made payable to: Cortland Figure Skating Club. The attached rates are set by USFSA and are as follows: \$60.00 for the first family member and \$24.00 for subsequent members. Additionally, there is a collegiate membership for \$70.00 that is good for four (4) years. If you are already a collegiate member with us, please disregard this letter.

There is a fee to be part of the Cortland Figure Skating Club. This year, Home Club Members (those who register with USFSA with us) will pay \$40. Associate Members (those who register with USFSA with a different Club) will pay \$75. This payment can be made when you fill out our Membership packets. Information will be coming out about this soon.

As part of the SafeSport program through USFSA, all families are required to sign the SafeSport Statement for Membership Renewal. If you have any questions about this program, please visit www.usfigureskating.org/SafeSport. Please return your signed SafeSport Statement with your membership renewal to be eligible for USFSA membership.

Please don't forget to complete and return the Club Member packet once it is sent out.

SafeSport Statement for Membership Renewal

The following code of conduct applies to all participants in activities hosted, supported, sponsored or engaged in by U.S. Figure Skating and Cortland Figure Skating Club, Inc. including but not limited to competitions, exhibitions, training camps and local rink activities.

I recognize that my participation or my child's in all the activities associated with U.S. Figure Skating and Cortland Figure Skating Club, Inc. is an honor and privilege that carries certain responsibilities. I agree to fully abide by the rules and guidelines set forth by U.S. Figure Skating or its properly designated agents.

U.S. Figure Skating Member Code of Conduct GR 1.02

I recognize that my participation in all activities hosted, supported, sponsored or engaged in by U.S. Figure Skating, including but not limited to competitions, exhibitions and training camps, is an honor and privilege that carries certain responsibilities. I agree to fully abide by the rules and guidelines set forth by U.S. Figure Skating or its properly designated agents. As a precondition to participation in activities hosted, supported, sponsored or engaged in by U.S. Figure Skating, I will adhere to the following tenets in good faith: **A.** I will exhibit the highest standards of fairness, ethical behavior and genuine good sportsmanship in all of my relations with others. **B.** I will not damage public or private property. I understand that I may be held financially responsible for damage deemed to be wantonly or willfully executed on my part, and that I may be subject to disciplinary action by U.S. Figure Skating. **C.** I will not use or possess illegal drugs, and I will not engage in criminal activity. I understand that, if I am found to use or possess illegal drugs, or if I am found to engage in any criminal activity during any activity hosted, supported, sponsored or engaged in by U.S. Figure Skating, I may be subject to criminal penalties as well as penalties imposed by U.S. Figure Skating. **D.** I will adhere to the rules of U.S. Figure Skating and the host organization at all activities hosted, supported, sponsored or engaged in by U.S. Figure Skating. **E.** I will comply with all applicable anti-doping rules including, but not limited to, ISU and USADA anti-doping rules. **F.** I will conduct myself in a manner not detrimental to the welfare of figure skating. I understand that my actions reflect on U.S. Figure Skating and the sport of figure skating both positively and negatively. I understand that if my acts, statements, or conduct are considered detrimental to the welfare of figure skating by the appropriate authority, I may be subject to penalties imposed by U.S. Figure Skating pursuant to GR 1.04. **G.** I understand that the penalties that may be imposed may include, but are not limited to, loss of future international selections, loss of financial support from U.S. Figure Skating and its Memorial Fund, and loss of participation in activities hosted, supported, sponsored or engaged in by U.S. Figure Skating. **H.** I understand that all disciplinary proceedings will be conducted pursuant to Article XXV, Section 3, of the U.S. Figure Skating bylaws, and that my rights and remedies are derived there from.
